

**Plymouth Ordinance: SEC. 11-2-18 CONDUCT AND OPERATORS OF PARADE UNITS.** (a) No person shall throw, dispense, or give away any candy, toys, souvenirs, or similar giveaways from any parade vehicle, float, or unit. (b) Any operator of a motorized parade vehicle, float, or unit shall have a valid driver's license. Any operator of an all-terrain vehicle, utility terrain vehicle, electric personal assistive mobility device, golf cart, or lawnmower shall be at least 14 years of age. Any tractor operator shall be at least 14 years of age and hold an applicable operator safety certificate.

### **POLICIES**

1. Plymouth has an ordinance (11-2-18) concerning parades and safety. Candy and other items **MAY NOT** be thrown from a float or vehicle. Items must be distributed by WALKING participants only.
2. Entries can be a float, vehicle, trailer, horse or walking participants.
- 3. All entries MUST be decorated to showcase a CHEESE/CHEESE CAPITAL OF THE WORLD theme.**
4. Music, live or recorded, is encouraged.
5. If an animal is entered, someone **MUST** follow the animal for "clean up"-this includes the lineup area.
6. All entries must follow the direction of the Plymouth Police Department as well as the "Lineup Committee."
7. After the parade, please be patient and continue the route until exiting on Forest or Edna Street.
8. The Plymouth Chamber reserves the right to remove any entry deemed inappropriate before the start of the parade.

### **RELEASE AND INDEMNIFICATION**
