- Vendor check-in/set up starts at 8:00 am the day of the event. Please be respectful to the staff and volunteers who are preparing for vendor arrivals and plan to arrive no earlier than 7:00 am.
- All vehicles must be removed from Mill Street by 9:45 am. Vendors are to stay set up until 4:00 pm. Early booth dismantling will make you ineligible for future events.
- Booths are 15 feet wide. You will need to bring any tents, tables, etc. for your space.

You can bring a canopy tent if needed (a 10x10 works well.) **If you need more than 15 feet, you must register and pay for 2 spaces!** Booth placements will not be completed until all registration forms are in. **You will receive notice the week of September 26th with booth set up information.**
